In the identified area, the current year population is 100,698. In 2010, the Census count in the area was 97,618. The rate of change since 2010 was 0.59% annually. The Diversity Index, which measures the probability that two people from the same area will be from different race/ethnic groups, is 72.0 in the identified area, compared to 63.0 for the U.S. as a whole.

Currently, 51.4% of the 45,135 housing units in the area are owner occupied; 40.1%, renter occupied; and 8.5% are vacant. Currently, in the U.S., 55.7% of the housing units in the area are owner occupied; 32.8% are renter occupied; and 11.6% are vacant. In 2010, there were 42,370 housing units in the area - 52.4% owner occupied, 40.7% renter occupied, and 6.9% vacant. The annual rate of change in housing units since 2010 is 2.85%. Median home value in the area is \$168,936, compared to a median home value of \$200,006 for the U.S. In five years, median value is projected to change by 2.92% annually to \$195,038.
