City of Las Cruces - Focus

- 2017 Council Strategic Plan -Reestablish air service with 20,000 enplanements
- 2019 City commissioned Phase I air service feasibility study.
- 2019 2020 City commissioned
 West Mesa Industrial Park, now Las
 Cruces Innovation and Industrial
 Park (LCIIP), Economic Assessment,
 Target Sector plan opportunities,
 strategy and implementation
 guidelines.

- 2021 City commissions Phase II Air Service Development Plan focusing on Intra and Inter-State Air Service.
- 2021, August. City Council adopts
 LCIIP Master Plan; Review and adopt
 Resolution affirming desire to re establish air service.
- 2021, August. CLC ED Dept. is developing an economic impact report in support of the 2021 New Mexico Rural Air Service Enhancement grant.
- 2021, August. LRU Airport Master Plan to be updated.

LRU Air Service Research Highlights

- In 2019, approx. 650 daily Las Cruces-area visitors or residents arriving and 650 daily departing via El Paso Airport (ELP)
- Las Cruces-area visitors or residents represent ~13.6% of the ELP traffic or ~237,000 annual enplanements

LRU Air Service Interstate Conclusions:

- Dallas Fort Worth (183 connecting cities) and PHX (83 connecting cities) are best fit for LRU nonstop interstate service
- Enough demand to have 2-4 daily interstate flights on 50-76 seat jet aircraft
- LRU will require facility and infrastructure improvements











Air Alliance Overview - Interstate

- Typically, public-private non-profit organizes (or a part of a non-profit) that focuses on air service development
- Alliances have been adopted by communities across the US, including New Mexico
- Grassroots effort: Encourage everyone in a community to have "skin in the game"











Connecting Las Cruces with New Mexico, the World, and Beyond!

- Las Cruces Air Alliance is in the initial stages of development
- Goal: Collaboration with City on intra- and interstate air service development
- Primary partners: Greater Las Cruces Chambers of Commerce, MVEDA, Virgin Galactic, NMSU, business community
- Air Alliance will hold frequent meetings with stakeholders











NM DOT Air Service Enhancement Act – Intra-State













NM DOT Rural Air Service Enhancement Act Overview

- New Act and funding approved during 2021 Legislative Session
- Coop funding opportunity to develop reliable intrastate scheduled air service
- Grant available up to \$1.75M/year for two years
- Requires 10% matching funds from successful awardee
- Opportunity to develop frequent year-round air service to Albuquerque and potentially Santa Fe during legislature session












Air Service Enhancement Overview

- ABQ top desired destination from LRU by businesses and residents
- In 2020, ~18,000 annual trips (~50 daily) between LRU and ABQ













Grant Funding Requirements

- Grant details:
 - \$1.75M/year for two years = \$3.5M
 - Requires 10% match or \$175k/year for two years = \$350k
 - Plus ~\$50k for marketing program for two years
 - Total funding will be \$400K over two years
- July 26, 2021 Council consensus to move forward











Intra-State Next Steps

- NM DOT Rules and Regs release
- Develop RFP to solicit interest and select air carrier
- Submit grant application
- Council approval upon successful grant award
- Infrastructure Improvements

Notes:

- 1. At 10,000 enplanements, FAA annual funding increases from \$150,000 to \$1,000,000.
- 2. Jobs created include LRU Support Staff; TSA station manager and support staff; Airline station manager, ticketing and ground support staff; rental car staff; ground transportation staff. Many of the FTEs are Union/high paying jobs.
